II. DECEMBER 2022 PLENARY - MAJOR DECISIONS



The Venice Commission held its 133d plenary session in Venice, at the Scuola Grande di San Giovanni Evangelista, on 16-17 December 2022, and **adopted the following opinions on:**

- the amendments to the Judicial Code of **Armenia**, jointly with the DGI;
- certain questions related to the Law of **Armenia** on Forfeiture of Assets of Illicit Origin (*amicus curiae* brief);
- draft amendments to the Election Code and the Law on Political Associations of Citizens of **Georgia**, jointly with the OSCE/ODHIR;
- the draft law of **Kosovo** N°08/L-121 on the State Bureau for verification and compensation of unjustified assets (a follow-up opinion);
- declaring a political party unconstitutional (the *amicus curiae* brief for the Constitutional Court of the **Republic of Moldova**);
- the draft law on the Supreme Court of Justice of the **Republic of Moldova** (joint follow-up opinion with the DGI);
- the draft amendments to the Law on the Judicial Council and Judges of **Montenegro**;
- legislation of **Serbia**, namely, on:
 - two draft laws implementing the constitutional amendments on the prosecution service,
 - three revised draft laws implementing the constitutional amendments on the Judiciary,
 - the constitutional and legal framework governing the functioning of democratic institutions - Electoral law and electoral administration;
- the amendments to certain legislative acts of **Ukraine** on improving the procedure for the selection of candidates for the position of judge of the Constitutional Court on a competitive basis.

The Commission **endorsed:**

- the **urgent opinions** on three laws concerning the justice system of **Romania** and on the amendments to the draft law on amendments to the Law on the President of **Montenegro**;
- the **compilation** of Venice Commission opinions and reports on **vetting of judges and prosecutors**.

- **MONTENEGRO – The Constitutional Court should become operational with no further delay - Statement by the President - 23/11/2022**

Paris – On 23 November 2022 the President of the Venice Commission, Ms Claire Bazy Malaurie, has made the following statement:

"Constitutional courts are the guardians of constitutions.

It is essential and urgent that the Constitutional Court of Montenegro be allowed to exercise its role at this time of deep institutional crisis in the country.

I therefore call on all the political forces sitting on the parliament of Montenegro to show their commitment to the democratic functioning of the institutions of the state and to elect without any further delay the four missing judges of the

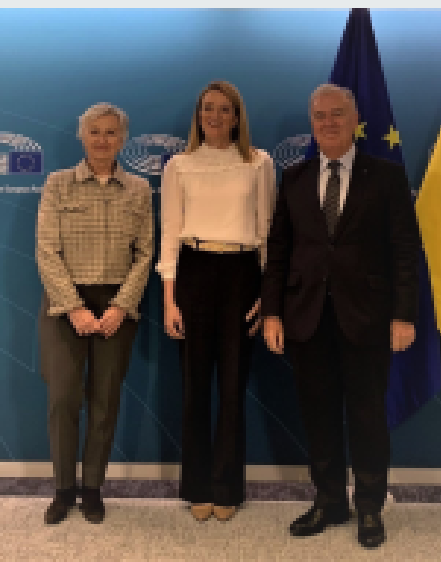
Constitutional Court by a qualified majority, as stipulated by the Constitution in order to ensure a pluralist composition of the Court.

The implementation of the Constitution requires the loyal cooperation among all state institutions. "

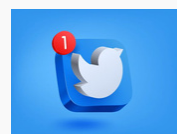
