#### BOSNIA AND HERZEGOVINA, BRAZIL AND BULGARIA - ELECTIONS - 2 OCTOBER 2022

General elections will be held in Bosnia and Herzegovina and in Brazil (presidency and vice-presidency, state governors and vice-governors, State Legislative Assemblies and the Legislative Chamber of the Federal District) on 2 October. The Venice Commission assisted the election observation mission of the Parliamentary Assembly of the Council of Europe (PACE) in Bosnia and Herzegovina and the Electoral Accompaniment Mission of the Global Network on Electoral Justice (GNEJ) in Brazil. The same day early parliamentary elections took place in Bulgaria and a representative of the Commission assisted the election observation mission of the PACE.

## EXCHANGE OF VIEWS BETWEEN THE PRESIDENT OF THE VENICE COMMISSION AND THE COMMITTEE OF MINISTERS - STRASBOURG, COUNCIL OF EUROPE, 07/09/2022



The presentation of the 2021 activity report and annual exchange of views with the Committee of Ministers took place on 7 September 2022 in Strasbourg.

The Venice Commission President underlined the substantive and substantial work which the Commission carried out last year, and continues to carry out in 2022. The increase in opinion requests has become structural (50 texts adopted in 2021 in relation to 23 countries – 1/3 from the European Union, compared to 32 in 2020 and 26 in 2019); some 25 opinion requests have already been received in 2022.

The majority of ambassadors intervened in the exchange of views, expressing satisfaction as to the pertinence, quality, results and impact of the Commission's work. Several ambassadors expressed support for an increase in the Commission's budget.

Further exchange of views with the President of the Commission, specifically devoted to the implementation of the Commission's recommendations, is planned before the end of the year.

The 2022 Rule of Law report of the European Commission was published on 13 July 2022. It contains numerous references to the Venice Commission's opinions.

Text of the Report

#### EU CANDIDATE STATUS FOR UKRAINE AND THE REPUBLIC OF MOLDOVA

On 23 June 2022, the European Council decided to grant the status of candidate country to Ukraine and to the Republic of Moldova. It invited the European Commission to report to the Council on the fulfilment of the conditions specified in the Commission's opinions on the respective membership applications as part of its regular enlargement package. The European Council expressed readiness to grant the status of candidate country to Georgia once the priorities specified in the Commission's opinion on Georgia's membership application have been addressed.

## "CIVIL SOCIETY: EMPOWERMENT AND ACCOUNTABILITY" INTERNATIONAL ROUND TABLE



Strasbourg, Council of Europe, 13/09/2022 - The International round table on "Civil society: empowerment and accountability" focused on two topics: participation of the civil society organisations in the public life and the regulations of foreign-funded associations. The round table was opened by the Secretary General of the Council of Europe, and addressed by the President of the Venice Commission, the Director of the ODIHR, the Minister for European Affairs of Ireland, the President of the PACE, Human Rights Commissioner, the Director of the Fundamental Rights Agency, and the UN Special Rapporteur on the Freedom of Association.

Speakers at the round-table included experts in international standards, members of the Venice Commission and the ODIHR experts, representatives of domestic and international NGOs and of the national authorities from countries with a relevant experience. The event was attended by several ambassadors, representatives of NGOs and international bodies based in Strasbourg. The round-table was organised in a hybrid format with over 50 participants present in the conference room and other 60 following the event online.

## III. JUNE 2022 PLENARY SESSION - MAJOR DECISIONS



The Venice Commission held its 131st Plenary Session in Venice, at the Scuola Grande di San Giovanni Evangelista, on 17-18 June 2022, and **adopted the following opinions on:**

- the draft law N°08/L-121 on the State Bureau for Verification and Confiscation of Unjustified Assets of Kosovo;

The Commission also adopted the <u>Explanatory Report of the Code of Good Practice on Referendums</u> and <u>endorsed</u> the Urgent Opinion on the constitutional and legislative framework on the referendum and elections announcements by the President of the Republic, and in particular on the decree-law n°22 of 21 April 2022 amending and completing the organic Law on the Independent High Authority for Elections of <u>Tunisia</u> (<u>ISIE</u>).

In the course of the 131st plenary, the Commission exchanged views with:

- Mr Matteo Mecacci, **Director** of the OSCE Office for Democratic Institutions and Human Rights (**ODIHR**);
- Mr Didier Reynders, European Commissioner for Justice;

- Representatives of the authorities of Kosovo, Lebanon, Republic of Moldova and Türkiye.

Upon the recommendation of the Enlarged Bureau, the Commission **elected** for a mandate expiring in December 2023 **Chairs of the Sub-Commissions on Federal and Regional State, the Mediterranean Basin and Ombudsman Institutions**, and was informed of the election by the **Council for Democratic Elections** (CDE) of the President of the CDE.

# HOLDING REFERENDUMS DURING WARS AND MILITARY THREATS IS AGAINST EUROPEAN STANDARDS - 21/09/2022

As the Secretary General of the Council of Europe, Marija Pejčinović Burić, has reminded in her statement of 15 September 2022, in 2014 the Venice Commission adopted an opinion on the organisation by the Autonomous Republic of Crimea in Ukraine of a referendum of 15 September 2022, in



2014 the Venice Commission adopted an opinion on the organisation by the Autonomous Republic of Crimea in Ukraine of a referendum on becoming a constituent territory of the Russian Federation.

The Venice Commission found that the circumstances prevailing in Crimea had not allowed for the holding of a referendum in line with European democratic standards. The Commission also warned that any referendum on the status of a territory should be preceded by serious negotiations among all stakeholders.

The conclusions of the Venice Commission expressed in the 2014 context apply mutatis mutandis to today's situation.

The Venice Commission has also stated in general that due to the difficulties to guarantee free campaigning and public debate on reforms with a longer effect, holding referendums during states of emergency, including war and military threats, would go against European standards.
