RECENT DEVELOPMENTS (1/2)

NEW KINDS OF OPINIONS

Following a meeting of the Commission's Bureau on 22 November, a new kind of opinions - **the Follow-up Opinions** - will be prepared when a country or the body which had requested an opinion further requests the Commission's assessment of the legal text revised in the light of the Commission's recommendations. These follow up opinions will only assess the compliance of the revised text with the Commission's previous recommendations and, as a norm, will not require country visits.

Three such opinions (on Serbia, Moldova and Kosovo) will be submitted to the Plenary for adoption in December.

VOLUNTARY CONTRIBUTIONS

The Commission has received a voluntary contribution of **€62,500 from Sweden**.

MONTENEGRO



Montenegro is undergoing a very deep political and institutional crisis, resulting in particular in difficulties in the formation of a new government following the vote of no confidence in the previous one in August 2022. The President has vetoed a law amending the Law on the President as concerns the President's powers to nominate a Prime Minister designate and has sought an urgent opinion of the Venice Commission.

The Constitutional Court of Montenegro is not operational, as parliament has failed to elect the four missing judges by qualified majority. The Venice Commission President has issued a **public statement** urging the election of the four constitutional court judges with no further delay. Both the adoption of the law and the election of the constitutional court judges are on the agenda of the Montenegrin parliament for 12 December. The urgent opinion will be issued shortly and will be submitted to the Plenary for endorsement in December.

RECENT DEVELOPMENTS (2/2)

ROMANIA



On the basis of a request from the PACE Monitoring Committee, the Commission prepared an **urgent opinion** on three - then - draft Laws concerning the justice system of Romania.

In view of ongoing discussions on whether the EU would terminate its Mechanism for Cooperation and Verification (CVM) in respect of Romania, the Minister of Justice asked for this opinion to be dealt with under the urgent procedure.

The urgent opinion, issued on 18 November 2022, made several recommendations on how to further improve the three laws but it concluded that - on the whole - they seemed to be heading in the right direction.

Referring *inter alia* to the urgent opinion, the European Commission concluded in its CVM Progress Report of 22 November 2022 that the progress made was sufficient to meet Romania's EU accession commitments. Future cooperation and monitoring of the justice system and anti-corruption policies in Romania should be carried out under the Rule of Law Report and the Rule of Law Toolbox that apply to all member States.

SERBIA



An opinion on the two laws implementing the constitutional amendments as to the prosecutions service, as well as a follow-up opinion on the revised laws implementing the constitutional amendments as to the judiciary will be submitted to the Plenary in December. These draft opinions were requested by the Minister of Justice of Serbia. Another, more general, draft opinion on the functioning of the democratic institutions in Serbia, requested by the

Parliamentary Assembly of the Council of Europe and focusing on the electoral legislation and its implementation, will also be submitted to the Plenary in December.

UKRAINE



Cooperation with the Ukrainian authorities has resumed. On 23 November, the **urgent opinion** on the draft law amending procedure for selecting candidate judges of the Constitutional Court of Ukraine, requested on 10 October by the Speaker of the Verkhovna Rada was issued. The Verkhovna Rada is expected to adopt the law, revised following the Commission's recommendations, shortly.

Work on the Law of Ukraine on the prevention of threats to national security, associated with excessive influence of persons having significant economic or political weight in public life (oligarchs) has resumed. More information on the timeframe will be given at the next Plenary Session.

III. MAJOR DECISIONS OF THE OCTOBER 2022 PLENARY SESSION



The Venice Commission held its 132nd plenary session in Venice, at the Scuola Grande di San Giovanni Evangelista, on 21 - 22 October 2022, and adopted the following opinions on:

- the law on the creation and functioning of the Ombudsman of **Andorra**;
- constitutional reform in **Belarus** and its compliance with Council of Europe standards - final opinion;
- the draft amendments to the Judicial System Act concerning the Inspectorate to the Supreme Judicial Council of **Bulgaria**;
- the draft amendments to the Criminal Procedure Code and the Judicial System Act of **Bulgaria**;
- the draft constitutional law on the Commissioner for Human Rights of **Kazakhstan**
- the amendments to the Audiovisual Media Services Code and to some normative acts including the ban on symbols associated with and used in military aggression actions of the Republic of **Moldova**;
- the clarity of provisions on combating extremist activity - amicus curiae brief for the Constitutional Court of the Republic of **Moldova**;
- the draft law on the Supreme Court of Justice of the Republic of **Moldova** - jointly with the Directorate General of Human Rights and Rule of Law (DGI) of the Council of Europe;
- the draft electoral code of the Republic of **Moldova** - the joint opinion of the Venice Commission and OSCE/ODIHR ;
- relating to the offence of illicit enrichment - the joint with OSCE/ODIHR amicus curiae brief for the Constitutional Court of the Republic of **Moldova** ;
- the draft constitutional amendments concerning the electoral system of **Mexico**,
- three draft laws of **Serbia** implementing the constitutional amendments on the Judiciary,
- certain questions related to the election and discipline of the members of the High Council of Justice of **Ukraine** - the joint amicus curiae brief of the Venice Commission and the Directorate General of Human Rights and Rule of Law (DGI) of the Council of Europe for the Constitutional Court;

The Commission also adopted the comments on Recommendation 2235 (2022) of the Parliamentary Assembly of the Council of Europe: “Recent challenges to security in Europe: what role for the Council of Europe?”, upon request by the Committee of Ministers of the Council of Europe.

- the Amendments to the Criminal Procedure Code adopted by the Parliament of **Georgia** on 7 June 2022, issued on 1 August 2022;

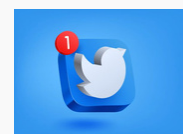
