MAIN DECISIONS

Venice, Scuola Grande di San Giovanni Evangelista - Due to the Covid-19 pandemic, the 129th Plenary Session was held in a hybrid form, in Venice and online, as it became customary, on 10-11 December 2021. The Venice Commission:

- adopted the following nine opinions on :
- <u>Albania Opinion on the Extension of the Term of Office of the Transitional Bodies in charge of the re-evaluation of</u> Judges and Prosecutors
- Cyprus Opinion on three Bills reforming the Judiciary
- Hungary Opinion on the compatibility with international human rights standards of Act LXXIX amending certain Acts for the protection of children
- Kazakhstan Opinion on the draft law "On the Commissioner for Human Rights",
- Kosovo Opinion on the draft amendments to the Law on the prosecutorial Council of Kosovo
- Republic of Moldova:
 - o Amicus curiae Brief for the Constitutional Court on the constitutional Implications of the ratification of the Council of Europe Convention on preventing and combating violence against women and domestic violence (Istanbul Convention);
 - o <u>Joint opinion of the Venice Commission and the Directorate General of Human Rights and Rule of Law (DGI) of the Council of Europe on some measures related to the selection of candidates for administrative positions in bodies of self-administration of judges and prosecutors and the amendment of some normative acts;</u>
 - Opinion on the amendments of 24 August 2021 to the law on the prosecution service
- <u>Ukraine Joint Opinion of the Venice Commission and the OSCE/ODIHR on the draft law "On improving the procedure for establishing the impossibility of holding national and local elections, all-Ukrainian and local referenda in certain territories and polling stations",</u>
- endorsed two Urgent opinions on Serbia: <u>Urgent opinion on the revised draft Law on the Referendum and the</u> People's Initiative and Urgent opinion on the revised draft constitutional amendments on the judiciary.
- Following the proposals made by the Committee of Wise Persons, the Commission elected for a term of two years its President, members of the Bureau and chairs of the sub-commissions.

New President of the Venice Commission meets the Secretary General of the Council of Europe - 12/01/2022

Strasbourg, Council of Europe – The newly elected President of the Venice Commission, Ms Claire Bazy Malaurie, paid a working visit to the Council of Europe on 12 January 2022. In the course of the visit the President met with the Secretary General of the Council of Europe, Ms Marija Pejčinović Burić. The dignitaries exchanged views on current democratic challenges faced by the Council of Europe's member States and the assistance the Commission is providing to them.

Ms Claire Bazy Malaurie, member of France's Constitutional Council since 2010, elected new Venice Commission President - 10/12/2021

Venice – Ms Claire Bazy Malaurie, member of the Constitutional Council of France since 2010, today was elected President of the Venice Commission, succeeding Gianni Buquicchio, who has been President since 2009. Her two-year term begins today, and she would be eligible for re-election in 2023. She has been a member of the Venice Commission since 2014.

A graduate of the National School of Administration in France (1978-1980), Madame Bazy Malaurie has held many varied positions in the French government, from Senior Public Auditor of the French Court of Audit (1990-1994) to Director of Hospitals at the French Ministry of Health and Social Affairs (1995-1998). She was member of the Commission for the compensation of victims' losses due to anti-Semitic legislation established during the Nazi Occupation of France (1999-2002) and mediator for collaboration with the academic community on a decree modifying the status of professors (2009). Honours she has received include Officier de la Légion d'honneur (2009) and Officier de l'Ordre national du Mérite (2005). Gianni Buquicchio will continue working with the Venice Commission as "Special Representative".
