Background and rationale

The Parliamentary Assembly of the Council of Europe observed the October 2015 presidential election in Belarus as part of an international election observation mission together with the OSCE/ODIHR and the OSCE PA. PACE welcomed the fact that it was invited to observe this election for the first time since 2001.

In its election observation report the PACE pointed out that “Belarus needs to reform its electoral legislation to ensure a thoroughly competitive political environment which is a key condition for the long-term democratic stability of the country” and concluded the Council of Europe and its Parliamentary Assembly, through their various co-operation programmes, should continue to strive to improve the electoral legislation and its implementation in Belarus.

The OSCE/ODIHR final report, which was published on 28 January 2016, included a number of recommendations addressed to national authorities, political parties and civil society of Belarus to support their efforts to hold elections in line with the OSCE commitments and standards for conducting democratic elections.

The PACE Rapporteur on the situation in Belarus, Mr Andrea Rigoni (Italy, ALDE), proposed to the Belarusian side to hold a roundtable on the electoral process improvement in the National Assembly of the Republic of Belarus with participation of the PACE and the Venice Commission representatives. According to the PACE Rapporteur, the forthcoming parliamentary elections in Belarus in 2016 are essential for further interaction.

The round table will be organized within the 2015-2017 EU-CoE Eastern Partnership Programmatic Co-operation Framework (PCF) in co-operation with the National Assembly of the Republic of Belarus and aims at public discussion of the improvement of the electoral process in the Republic of Belarus in regard to the PACE and OSCE/ODIHR recommendations.
