#### 28-29 May 2015 – Johannesburg, South Africa

- Exchange of views with the Executive Committee of the International Association of Constitutional Law (IACL) on the organization of a roundtable in Venice (October 2016).
- Attending the conference on "the "New" separation of powers: can the doctrine evolve to meet the C21 context?" organised by IACL and Johannesburg University.
- Meeting with Mr Mogoeng Mogoeng, Chief Justice of South Africa, on the crisis affecting constitutional justice in the region.

#### 3 June 2015 - Strasbourg

- Presentation of the Venice Commission's Annual Report of activities 2014 to the Committee of Ministers of the Council of Europe, questions and answers.

#### 4 June 2015 - Paris

- Opening address at the Parliamentary Conference on implementation of the Right to Free Elections: the challenge of applying election legislation and the Council of Europe standards, co-organised by the Parliamentary Assembly of the Council of Europe and the National Assembly of France.

### 5 June 2015 - Rome, Italy

- Discussant at the Conference on "the current political challenges and opportunities in the Mediterranean Region" co-organised by the Parliamentary Assembly of the Council of Europe and the Italian Parliament with the participation of Mr Pietro Grasso, President of the Senate, Mr Benedetto della Vedova, Under Secretary for Foreign Affairs, Ambassador Luca Giansanti, Director General of Political Affairs and Security, Ms Hala Mustafa, Political Scientist from Egypt and Mr Abdul Rahman Al Ageli, co-founder of the Lybian South Forum.
