#### 24 May 2013 - Strasbourg

- Meeting with Mr Thorbjørn Jagland, Secretary General of the Council of Europe, on administrative issues.

## 27 May 2013 - Strasbourg

- Meeting with Mr Joost Korte, Deputy Director General of EU Enlargement, on cooperation with the Venice Commission.

#### 30-31 May 2013 - Arequipa, Peru

- Participation in the International Conference on "Individual access to Constitutional Justice in Latin America" co-organised by the Venice Commission and the Constitutional Tribunal of Peru.
- Lecture on the Venice Commission at the Catholic University of Santa Maria

#### 12 June 2013 – Strasbourg

- Meeting with Mr Stefan Füle, EU Commissioner for Enlargement, on co-operation with the Venice Commission on issues of common interest concerning candidate countries.

#### 19 June 2013 - Strasbourg

- Presentation of the Venice Commission's Annual Report to the Committee of Ministers of the Council of Europe.

#### 27 June 2013 - Brussels

- Address to the 72<sup>nd</sup> meeting of the EU-Turkey Joint Parliamentary Committee on the Turkish constitutional reform.

#### 3-4 July 2013 - Erevan, Armenia

- Participation in the Pan-European Conference on European standards of rule of law and the scope of discretion of powers in the Member States of the Council of Europe.
- Meetings with Mr Hovik Abrahamyan, Speaker of the Armenian Parliament, and with Mr Edward Nalbandian, Minister of Foreign Affairs of the Republic of Armenia.

### 29-30 August 2013 – Astana, Kazakhstan

- Opening address at the Conference on "the Constitution a basis of strategy of development of society and the State" organised by the Constitutional Council of Kazakhstan on the occasion of the Constitution Day of the Republic.
- Meetings with Mr Askhat Daulbayev, Prosecutor General, Mr Bektas Beknazarov, Chairman of the Supreme Court, and Mr Berik Imashev, Minister of Justice, on the implementation of the co-operation programmes between Kazakhstan and the Venice Commission.
