DRAFT ANNOTATED AGENDA

1. Adoption of the agenda

The Council is invited to adopt its agenda as it appears in this document.

2. Report on open and closed lists

A draft report on proportional electoral systems: the allocation of seats inside the lists (open/closed lists) has been prepared on the basis of comments by Mr Barrett, Mr Kask, Mr Mifsud Bonnici and Mr Kåre Vollan (Expert, Norway) (<u>CDL(2014)058</u>; see the comparative table, <u>CDL(2014)051</u>).

The Council is invited to adopt the draft report, with a view to its submission to the Commission at its March 2015 session. This report falls in the framework of the work on measures to improve the democratic character of elections in the member States of the Council of Europe (see Parliamentary Assembly report "for more democratic elections" (Doc. 13021) adopted in October 2012).

3. Criteria for standing in local and regional elections

At its June 2014 meeting, the Council examined a draft report by the Congress on "criteria for standing in local and regional elections". The Secretariat has prepared a memorandum which makes comments on the revised draft report (CG/GOV(27)5rev6, 1st version). The Congress' Governance Committee approved this document on 17 November 2014, with some amendments (CG/GOV(27)5rev6, 2nd version). This Committee has not yet taken the Secretariat's comments into consideration, but is ready to do so for a forthcoming meeting.

The representative of the Congress is invited to present the draft report and the Council is invited to take note of this report as well as of the Secretariat memorandum.

4. Electoral lists and voters abroad

Mr Wienen has prepared a preliminary draft report on "electoral lists and voters abroad" for the Congress' Monitoring Committee (CG/MON(26)13). He is invited to present this text and the Council is invited to take note of it.

Ms Alanis Figueroa prepared a memorandum on Latin American answers to problems of *de facto* living abroad, which is also submitted to the Council.

5. Work of the International Standards Organization (ISO) on electoral processes

As indicated at the March 2014 meeting, the ISO electoral administration norms was not adopted; however the text was approved as a <u>technical specification</u> (ISO/TS 17582:2014, Quality management systems — Particular requirements for the application of ISO 9001:2008 for electoral organisations at all levels of government). The Council will be informed on progress of work on the basis of the memorandum prepared by Ms Alanis Figueroa.

6. Co-operation with the Organization of American States (OAS)

The representative of the Organization of American States (OAS) is invited to present to the Council the activities of this Organization in the electoral field as well as possibilities for future co-operation.

7. European Conference of Electoral Management Bodies (information item)

The Secretariat will inform the Council on the state of preparation of the 12th European Conference of Electoral Management Bodies which will take place in Brussels on 30-31 March 2015 on "Ensuring neutrality, impartiality and transparency in elections: the role of Electoral Management Bodies." This Conference is organised in the framework of the Belgian Chairmanship of the Committee of Ministers of the Council of Europe, jointly with the Ministry of the Interior of Belgium.

8. Information about the current work and future activities

 - Assistance to the Central Electoral Commission of Moldova, on electoral disputes and including training of trainers (21-26 September 2014);
 - Assistance to the Parliamentary Assembly observation mission on the occasion of the parliamentary elections in Bulgaria (5 October 2014);
 - Workshop on the resolution of electoral disputes; organised prior to the Parliamentary elections in Ukraine (Kiev, 7 October 2014);
 - Assistance to the Parliamentary Assembly observation mission on the occasion of the parliamentary elections in Tunisia (26 October 2014);
