1. Adoption of the agenda

The Council is invited to elect a President and Vice-President.

3. Study - Recall of mayors and local elected representatives

The Council for Democratic Elections examined a first version of the draft report on the recall of mayors and local elected representatives in June 2018. It is invited to examine its revised version (CDL(2019)019) drawn up on the basis of comments by Mr Castellà Andreu, Ms Jametti and Ms Karakamisheva-Jovanovska before its submission to the Sub-Commissions on Democratic Institutions and the Mediterranean Basin and to the plenary session.

4. Study - Use of digital technologies and elections

In June 2017, the Council for Democratic Elections, upon an initiative by Mr José Luis Vargas Valdez and on the basis of his "Study on the role of social media and the internet in democratic development", decided to undertake a study on the use of social media during electoral processes, jointly with the Council of Europe's Information Society Department. The Council is now invited to examine the draft report (CDL(2019)002) drawn up on the basis of comments by Mr Barrett, Ms Kjerulf Thorgeirsdottir, Mr Rubio Nuñez, Mr Vargas Valdez, Ms Rozgonyi (DGI expert, Media and Internet Governance Division) and Ms Ruzic (DGI Expert, Data Protection Division) which should be submitted to the plenary session; see also CDL-REF(2019)009).

5. Study – Election dispute resolution

In March 2018, the Council had already been informed about the drafting of a preliminary study in the field. The Council is now invited to examine the draft report on this issue (CDL-EL(2019)001) drawn up on the basis of comments by Mr Holmøyvik, Mr Kask, Ms Pabel, Mr Vargas Valdez, Mr Dominioni (expert) and Mr Kalchenko (expert); see also CDL-REF(2019)010).
