## **MEETING REPORT**

## 1. Adoption of the agenda

The Council adopted its agenda as it appears in this document.

## 2. Election of the President and Vice-President

The Council elected Oliver Kask as President and Lord Balfe as Vice-President.

## 3. Study - Recall of mayors and local elected representatives

Ms Jametti informed the Council that the study was drafted at the request of the Congress, following the procedure for the recall of the mayor of Chişinău, in order to know whether the recall was in conformity with international standards. Recall had to be distinguished from revocation (by an institution); both were part of a political process, contrary to destitution, which was a legal measure. Recall had also to be distinguished from imperative mandate. It might exist at national, regional or local levels and concern individual members of the legislature or the executive, or the whole body and be initiated, for example, at the request of the people, of the municipal council or of a national institution. In practice, it existed, in law and in fact, above all in America (Ecuador, Peru, United States) as well as in Japan; in Europe, it was rather rarely applied. Where mayors were directly elected, recall (by a popular vote) might be possible, contrary to revocation. The European Charter of Local Self-Government did not take a position on this issue. While the Venice Commission was opposed to imperative mandate, it had not so far addressed the issue of recall in general, which was intended at reinforcing the links between the elected officials and the electorate but did imply risks. Since recall was a political process, it was not submitted to substantive conditions. In conclusion, recall was rarely used in practice, but it had to be subject to important safeguards and therefore be exceptional, and the various aspects of the procedure should be clearly dealt with by the law.

Ms Karakamisheva added that there was no European or international legal document on the issue. The situation of mayors elected directly or indirectly must be clearly distinguished. Like Mr Wienen, she stressed the importance of the distinction between political and legal responsibility.

The Council adopted the draft report on the recall of mayors and local elected representatives (CDL-AD(2019)011).

## 4. Study - Use of digital technologies and elections

Mr Vargas Valdez underlined the complexity of the matter, due to the borderless nature of the internet and the private ownership of information. Internet and social media had become essential in the electoral process, but electronic challenges to democracy, including cybercrime, were high. This implied that the issue be addressed from a legal point of view, that is, in practice, through international soft law standards. Regulation of the internet and social media had to respect freedoms, in particular, freedom of expression, economic freedom, the right to privacy and social rights. Key words were adaptability and international co-operation. Mr Vargas Valdez therefore suggested that the rapporteurs draft a set of principles on the matter after the adoption of the report.

Following a suggestion by Mr Rubio Nuñez, two slight amendments would be made on monitoring of funding of electoral campaigns and the issue of (false) personal profiles.

The Council adopted the draft joint report of the Venice Commission and of the Directorate of Information Society and Action against Crime of the Directorate General of Human Rights and Rule of Law on Digital Technologies and Election (CDL-AD(2019)016).

## 5. Study – Election dispute resolution

Mr Holmøyvik presented the draft report, especially its structure and the remaining issues to be clarified or developed according to the rapporteurs. The Council gave its agreement that the rapporteurs and the secretariat pursue their work on the draft report with the aim:

- of clarifying the terminology used as well as the legal situation in some states (grounds for filing electoral complaints, list of persons and categories of persons entitled to challenge the various phases of the electoral process, countries where parliaments deal with complaints on parliamentary elections);
- of creating an appendix with the detailed references of the reports, opinions and case-law indicated in the numerous footnotes;
- of restructuring the draft report with regard to the types of complaints concerned.

## 6. Communication by the Secretariat

Mr Kask informed the Council that a meeting of rapporteurs on updating the Code of Good Practice on Referendums had taken place before the meeting of the Council. It followed the adoption by the Parliamentary Assembly of Resolution 2251(2019) on Updating guidelines to ensure fair referendums in Council of Europe member States.

## 8. Co-operation with OSCE/ODIHR

The OSCE/ODIHR informed the Council on its current and future activities in the electoral field. Such information is contained in an appendix of the present report.

Mr Chahbazian pointed out the constructive co-operation with the OSCE/ODIHR in the context of International election observation missions. Recently, core teams of ODIHR referred in a more systematic manner to the proposals of Venice Commission experts in the draft preliminary conclusions and findings, but also to relevant reference documents of the Council of Europe and the case-law of the European Court of Human Rights.

## 9. Date of the next meeting

The Council fixed the date of its next meeting for Thursday, 10 October 2019 at 10.00 am.
