The Sub-Commission is invited to discuss the draft revised joint Guidelines on Freedom of Religion by the Venice Commission and the OSCE/ODIHR (CDL(2014)016) on the basis of comments by Ms Flanagan, Mr Vermeulen and members of the OSCE/ODIHR Panel.

5. Co-operation with the European Court of Human Rights

The Sub-Commission is invited to discuss the draft *amicus curiae* brief for the European Court of Human Rights (CDL(2014)009) on specific questions concerning parliamentary investigation committees (Case of Rywin v. Poland) with a view to its submission to the Plenary Session for adoption. This *amicus curiae* brief was drawn up on the basis of comments by Mr Frendo, Mr Scholsem and Mr Sejersted.
