The costs of publishing the *Bulletin on Constitutional Case-Law*, to be deducted from sales at the subscription price, are as follows:

- the discount granted to our distributors (sales agents, bookshops, subscription agencies), which ranges from 40 to 60% of the list price,
- carriage (averaging FRF 20 per volume),
- printing (which again averages FRF 20 per volume, but varies according to the number of copies and pages).

This therefore leaves an extremely small margin. The above calculation moreover disregards commercial follow-up expenses.

However, distributing the *Bulletin* in this way makes it possible to present it as a periodical (legal deposit, inclusion in directories, allocation of an ISSN) and to sell other Council of Europe publications to our regular customers.

A comparison with the subscription prices of various legal periodicals published in the same format shows that the selling price of the bulletin is quite reasonable.

For example:

- the Lamy social case-law bulletin (*Jurisprudence sociale Lamy*) offers subscribers about 700 pages per year for a total of FRF 1,511, which is considerably more than the price of the *Bulletin*;
- on a per-page basis the price of the law reports of the French *Conseil d'Etat* (six issues per year for an annual subscription of FRF 820) is comparable with that of the *Bulletin*; the law reports are even slightly more expensive.

Three tables are appended: the first is general, the second shows monthly and twice-monthly publications and the third periodicals with roughly the same frequency of publication as the *Bulletin*.
