## CONSTITUTIONAL CASE-LAW

The Bulletin on Constitutional Case-Law is a publication of the European Commission for Democracy through Law, also known as Venice Commission. Published in French and English, the Bulletin offers summaries of the most important decisions of constitutional courts and equivalent jurisdictions of Greater Europe and of several non-European countries, as well as decisions of the European Court of Human Rights and the European Court of Justice.

The novel concept and presentation of the Bulletin are aimed at quickly informing the reader of the key points of a decision. Following a brief presentation of the legal issues raised, the summary presents the case and the reasoning of the decision in its context. A systematic thesaurus especially developed by the Venice Commission and liaison officers of participating courts allows easy access to the information required.

The Bulletin thus offers a broad, periodic update on constitutional developments considered by around forty constitutional jurisdictions.

As the Venice Commission is eager to increase the distribution of case-law of constitutional courts and to provide a site for European constitutional case-law accessible to the widest possible readership, it edits a **CD-ROM CODICES**, which is a database of considerable proportions.

**CODICES** consists of all issues of the Bulletin and, most importantly, the full texts of decisions of constitutional courts throughout Europe and the full texts of the Constitutions of these countries, as well as the statutes of their constitutional courts.

**CODICES** corresponds to 10,000 pages of text, in which any kind of search is possible. Links have been established to allow the reader to jump from the summary of a decision to its corresponding full-text version or even directly to the relevant article of the constitution. For example, the user can quickly find the important European decisions relating to the freedom of the press, read certain full text versions of these decisions, refer to the relevant constitutional provisions and finally print the results of the search.

Constitutional issues affect all legal fields: the **Bulletin** and **CODICES** will be of interest to constitutional lawyers and all practitioners interested in the evolution of the law.

**The Venice Commission** was created in 1990 as a Partial Agreement of the Council of Europe. It consists of independent experts and its goal is to advise old and new democracies in the field of constitutional law.
