EUROPEAN COMMISSION FOR DEMOCRACY THROUGH LAW

Report of the 12th Meeting of the Sub-Commission on Constitutional Justice

(Venice, 16 October 1997)

The Sub-Commission on Constitutional Justice held its 12th meeting in Venice on 16 October 1996, with Mr Matthew Russell in the Chair. A list of participants can be found in Appendix I.

1. Adoption of the Agenda

The participants adopted the agenda set out in Appendix II.

2. Communication by the Secretariat

The Secretariat informed the Sub-Commission about the series of seminars which are being organised with Constitutional Courts. Since the 11th meeting of the Sub-Commission, a seminar had been held in Co-operation with the Constitutional Court of Karelia in Petrozavodsk (Russia) on the Relations between the Constitutional Court of the Russian Federation and Constitutional Courts of Subjects of the Russian Federation.

Other seminars planned until the end of 1997 were to take place in Yerevan (on Constitutional Control and the Protection of Human Rights), Tbilissi (The Execution of Decisions of Constitutional Courts) and in Baku (Essential Elements of a Constitutional Court). Some of these seminars are co-organised with USAID (Yerevan, Tbilissi), UNDP (Tbilissi) and COLPI (Yerevan, Tbilissi, Baku).

2. Study on the Composition of Constitutional Courts

The Sub-Commission discussed the draft Report on the Composition of Constitutional Courts (CDL-JU (97) 34).

Firstly, the Sub-Commission recalled the deadlines for sending replies to the questionnaire set at

its 11th meeting (comments until 20 July, new contributions until 15 August 1997) and decided that no further contributions could be taken into account.

The rapporteurs who attended (Messrs Robert and Vandernoot - Mr Zlinsky having sent his apology) presented the report and the conclusions they had drawn. The Sub-Commission discussed the report in detail and made certain changes with respect to information provided by the members of the Commission. The titles of the chapters were rearranged.

The Sub-Commission discussed in detail the point in the conclusions concerning the necessity that a decision to dismiss a member of the court should involve a vote by the court itself. It was pointed out that this did not correspond to the practice in some of the participating countries. Finally, however, the opinion prevailed that the conclusions of the report were not intended to summarise existing regulations but rather to point out directions which the Venice Commission considered desirable.

The Sub-Commission adopted the report with the amendments made (CDL-JU (97) 34rev).

4. Other business

The Sub-Commission recalled that it had accepted the invitation of the Belgian Court of Arbitration to hold its next meeting with liaison officers at the seat of the Court in Brussels on 31 October 1997. The Sub-Commission expressed its gratitude for this kind invitation.
