# EUROPEAN COMMISSION FOR DEMOCRACY THROUGH LAW OF THE COUNCIL OF EUROPE (VENICE COMMISSION)

## 145th PLENARY SESSION

Venice, 12-13 December 2025

## **SYNOPSIS**

#### The Venice Commission:

- Held an exchange of views with Ms Inese Lībiņa-Egnere, Minister of Justice of Latvia, and adopted the Opinion on the draft law of Latvia on the withdrawal from the Council of Europe convention on preventing and combating violence against women and domestic violence (the Istanbul Convention), previously examined by the Sub-Commission on International Law at its meeting on 11 December 2025;
- Held an exchange of views with Mr Igor Chiriac, Vice President of the Legal Commission for Nominations and Immunities from the Parliament of the Republic of Moldova, and adopted the Joint Opinion of the Venice Commission and the Directorate General Human Rights and Rule of Law (DGI) of the Council of Europe on the draft law of the Republic of Moldova on the Prosecution Office for Anticorruption and Combatting Organised Crime;
- Postponed the examination of the amicus curiae brief for the Constitutional Court of the Republic of Moldova on the status of, and the measures concerning, successor parties of political parties declared unconstitutional;
- Held an exchange of views with Mr Momo Koprivica, Deputy Prime Minister for Political System, Judiciary, and Anti-Corruption of **Montenegro**, and adopted the Follow-Up Opinion to the Opinion on some questions relating to the procedure of early termination of the mandate of Constitutional Court judges of Montenegro due to age limits;
- Held an exchange of views with Mr Arben Fetai, Deputy Prime Minister of the Republic of North Macedonia, and adopted the Opinion on the draft law of North Macedonia on adequate and fair representation, previously examined by the Sub-Commission on National Minorities at its meeting on 11 December 2025;
- Adopted the Opinion on the draft amendments to certain legislative acts of Ukraine regarding the improvement of the competitive selection process for the position of judge of the Constitutional Court of Ukraine:
- Adopted the amicus curiae brief for the European Court of Human Rights in the case of Kuijt v. the Netherlands on participation of additional judges in supreme court deliberations, previously examined by the Sub-Commissions on the Judiciary and on the Rule of Law at their joint meeting on 11 December 2025;
- Adopted the Updated Rule of Law Checklist, previously examined by the Sub-Commissions on the Judiciary and the Rule of Law at their joint meeting on 11 December 2025;
- Adopted the report on the status of the European Charter of Local Self-Government in the domestic legal order of Council of Europe member States, previously examined by the Sub-Commission on International Law at its meeting on 11 December 2025;
- Endorsed the compilation on parliamentary autonomy (Inquiry Committees and Immunities)
  and was informed of updates of the compilations relating to qualified majorities and antideadlock mechanisms and to Judicial Councils;
- Postponed consideration of the report on freedom of expression, prohibition of hate speech and promotion of pluralism in the context of electoral campaigns;
- Was informed on the follow-up to the Opinion on amendments to the Audiovisual Media Services Code and to some normative acts including the ban on symbols associated with and used in military aggression actions and to the Opinion on the legislative reforms on mass media regulation: the draft law on mass media, the draft law amending the Audiovisual Media

Services Code, and the draft law amending the Law on Advertising of the Republic of Moldova; to the Brief to the Constitution Committee of the House of Lords of the United Kingdom in relation to its inquiry into the Rule of Law; to the **Report on a rule of law and human rights compliant regulation of spyware**; and to the Report on Term Limits - Part I – Presidents;

- Was informed of the results and conclusions of the meeting of the Council for Democratic Elections on 11 December 2025;
- Was informed on the participation of the Venice Commission as legal advisor in the **electoral observation missions** of the Parliamentary Assembly of the Council of Europe and of the Organization of American States, and international visitors programmes for elections;
- Authorised the preparation of an urgent opinion on recently adopted and pending amendments to the legislation on the National Radio and Television of **Lithuania**, at the request of the latter;
- Decided not to pursue its work on the preparation of a report on democratic governance of the European Union;
- was informed on constitutional developments in Japan;
- following the proposals made by the Committee of Wise Persons, elected for a term of two years:

R. Deskoska (North Macedonia), E. Holmøyvik (Norway) and T. Otty (United Kingdom) as Vice-Presidents;
