EUROPEAN COMMISSION FOR DEMOCRACY THROUGH LAW (VENICE COMMISSION)

ORGANIC LAW OF GEORGIA

ON CHANGES

TO THE ELECTION CODE OF GEORGIA

(ON REDRAWING OF CONSTITUENCIES)

ADOPTED ON 8 JANUARY 2016

Article 1. Organic Law of Georgia on the "Election Code of Georgia" (Legislative Herald of Georgia (www.matsne.gov.ge), 10.01.2012, registration code: 010190020.04.001.016032) shall be amended as follows:

1. Article 14, paragraph 1, subparagraph "e" shall be formed as follows:

"e) by an ordinance, set up election districts and/or specify their boundaries in accordance with the procedures prescribed by this Law; ".

2. Article 18 shall be formed as follows:

"Article 18. Election Districts

1. Election districts, their boundaries, titles and numbers shall be determined in accordance with this Law by a CEC ordinance, except for cases defined by paragraph 2 of this Article.

2. For the elections of the Parliament of Georgia, majoritarian districts shall be set up, their boundaries and numbers shall be determined in accordance with this Law and based on the procedures set by Articles 110 and 110¹ of this Law."

3. Paragraph 2 of Article 19 shall be formed as follows:

"2. The CEC is authorized to set up, by an ordinance, one DEC within boundaries of one or more self-governing units and 10 DECs in Tbilisi.".

4. Article 110 shall be formed as follows:

"Article 110. Rule of formation of majoritarian election districts for the elections of the Parliament of Georgia

1. For the elections of the Parliament of Georgia, 73 single-mandate majoritarian election districts shall be set up.

2. Majoritarian election districts shall not be set up in the occupied territories of Georgia as defined by the Law of Georgia on Occupied Territories.

3. The number of registered voters in majoritarian election districts must comply with internationally recognized standards and ensure, to a feasible extent, equal distribution of voters in election districts.

4. Majoritarian election districts shall be set up and their boundaries defined by this Law and a CEC ordinance. Numbers of election districts shall be set by the CEC ordinance no later than June 1 of the regular parliamentary election year and no earlier than December 1 of the previous year.

5. Majoritarian election districts are set up by a CEC ordinance and their boundaries defined in accordance with this Article and Article 110¹ of this Law for municipalities in which formation of two or more election districts is envisaged, if boundaries of election districts have not been set by this Law.

6. Majoritarian election district may comprise one or more adjacent municipalities fully, (except for cases defined by paragraph 28 of Article 110¹ of this Law), neighboring local majoritarian election districts of one municipality or adjacent municipalities, and in cases envisaged by paragraph 5 of this Article - also, adjacent local majoritarian election districts fully or partially.

7. During the period between regular parliamentary elections and the next regular elections, by-elections and pre-term elections of the Parliament of Georgia shall be held according to the election districts defined by paragraphs 4 and 5 of this Article, boundaries of which stay unaltered during this period despite the possible changes to the administrative boundaries of municipalities and boundaries of local majoritarian election districts.

8. Latest data from the CEC electronic database of the general lists of voters shall be used when setting up majoritarian election districts. In cases defined by paragraph 5 of this

Article, CEC shall use the same electronic database of the general lists of voters that was used to set up the boundaries of districts by this Law.".

5. Articles 110^1 and 110^2 shall be added as follows:

"Article 110¹. Majoritarian election districts for the elections of the Parliament of Georgia

1. For the regular elections of the Parliament of Georgia, local majoritarian election districts envisaged by paragraph 6 of Article 110 of this Law are to be considered as the local majoritarian election districts that were set up for the last municipal elections conducted before these elections.

2. 22 majoritarian election districts shall be set up within Tbilisi city municipality and the local majoritarian election district of Martkhopi of Gardabani municipality.

3. Each majoritarian election district shall be set up within the boundaries of Sagarejo, Gurjaani, Khashuri, Sachkhere, Chiatura, Tskaltubo and Samtredia municipalities.

4. 1 majoritarian election district shall be set up within the boundaries of Signagi and Dedoplistsqaro municipalities.

5. 1 majoritarian election district shall be set up within the boundaries of Lagodekhi municipality and the local majoritarian election districts of Akhalsopeli, Baghlojiani, Chikaani, Kuchatani, Gavazi and Mtisdziri of Kvareli municipality.

6. 1 majoritarian election district shall be set up within the boundaries of local majoritarian election districts of Akura, Kisiskhevi, Kondoli, Kurdgelauri, Kvemo Khodasheni, Shalauri and Tsinandali of Telavi municipality and local majoritarian election districts of City of Kvareli, Shildi, Eniseli, Sabue and Gremi of Kvareli municipality.

7. 1 majoritarian election district shall be set up within the boundaries of the Akhmeta municipality and the local majoritarian election districts of Gulgula, Vardisubani, Tetritsklebi, Ikalto, Napareuli, Ruispiri, Saniore, Pshaveli, Karajala and Artana of Telavi municipality.

8. 2 majoritarian election districts shall be set up in the Rustavi City municipality.

9. 1 majoritarian election district shall be set up within the boundaries of majoritarian election districts of the City of Gardabani, Vakhtangisi, Kalinino, Lemshveniera, Nazarlo, Sartichala, Kesalo, Norio and Jandari of Gardabani municipality.

10. 1 majoritarian election district shall be set up within the boundaries of Tetritskaro municipality and the local majoritarian election districts of Kumisi, Teleti, Krtsanisi, Akhali Samgori, Gamarjveba, Agtaklia, Karataklia, Karajalari and Akhali Sopeli of Gardabani municipality.

11. 1 majoritarian election district shall be set up in Bolnisi municipality, except for the local majoritarian election district of Kazreti.

12. 1 majoritarian election district shall be set up within the boundaries of Tsalka and Dmanisi municipalities and the local majoritarian election district of Kazreti of Bolnisi municipality.

13. 1 majoritarian election district shall be set up within the boundaries of the local majoritarian election districts of Algeti, Kasumalo, Sadakhlo, Kapanakhchi, Kutliari, Kachagani and Kulari of Marneuli municipality.

14. 1 majoritarian election district shall be set up in the local majoritarian election districts of the City of Marneuli, Kizil-Ajlo, Tamarisi, Tsereteli, Damia-Geurarkhi, Shulaveri, Shaumiani, Tserakvi, Khojorni, Akhkerpi and Opreti of Marneuli municipality.

15. 1 majoritarian election district shall be set up within the boundaries of the Mtskheta City municipality and Mtskheta municipality.

16. 1 majoritarian election district shall be set up within the boundaries of Dusheti, Kazbegi and Tianeti municipalities.

17. 1 majoritarian election district shall be set up within the boundaries of Kaspi municipality and local majoritarian election district of Kvakhvreli of Gori municipality.

18. 1 majoritarian election district shall be set up within the boundaries of Kareli municipality and local majoritarian election districts of Variani and Shindisi of Gori municipality.

19. 1 majoritarian election district shall be set up within the boundaries of the Gori City municipality and local majoritarian election districts of Tiniskhidi and Berbuki of Gori municipality.

20. 1 majoritarian election district shall be set up in the Gori municipality, except for the local majoritarian election districts of Kvakhvreli, Variani, Shindisi, Tiniskhidi and Berbuki.

21. 1 majoritarian election district shall be set up within the boundaries of municipalities of the City of Akhaltsikhe, Akhaltsikhe and Adigeni.

22. 1 majoritarian election district shall be set up within the boundaries of Borjomi municipality, Aspindza municipality and local majoritarian election districts of Azavreti, Kochio, Ptena, Baraleti and Chunchkha of Akhalkalaki municipality.

23. 1 majoritarian election district shall be set up within the boundaries of Ninotsminda municipality and Akhalkalaki municipality, except for local majoritarian election districts of Azavreti, Kochio, Ptena, Baraleti and Chunchkha.

24. 3 majoritarian election districts shall be set up within the boundaries of the Kutaisi City municipality and local majoritarian election districts of Kvakhchiri, Chognari and Godogni of Terjola municipality.

25. 1 majoritarian election district shall be set up within the boundaries of Tkibuli municipality and Terjola municipality, except for the local majoritarian election districts of Kvakhchiri, Chognari and Godogni.

26. 1 majoritarian election district shall be set up within the boundaries of Kharagauli municipality, Baghdati municipality and local majoritarian election districts of Ilemi, Sanakhshire, Shrosha, Puti and Dzirula of Zestaponi municipality.

27. 1 majoritarian election district shall be set up within the boundaries of Zestaponi municipality, except for local majoritarian election districts of Ilemi, Sanakhshire, Shrosha, Puti and Dzirula.

28. 1 majoritarian election district shall be set up in the municipalities of Vani and Khoni.

29. 1 majoritarian election district shall be set up within the boundaries of the municipalities of the City of Ambrolauri, Ambrolauri, Oni, Lentekhi, Mestia and Tsageri.

30. 1 majoritarian election district shall be set up within the boundaries of the municipalities of City of Ozurgeti and Ozurgeti, except for the local majoritarian election districts of Natanebi, Ureki, Nagomari, Silauri, Dzimiti, Jumati, Baileti and Nasakirali.

31. 1 majoritarian election district shall be set up within the boundaries of Lanchkhuti municipality, except for the local majoritarian election districts of Supsa and Grmagele, Chokhatauri municipality and the local majoritarian election districts of Nagomari, Silauri, Dzimiti, Jumati, Baileti and Nasakirali of Ozurgeti municipality.

32. 1 majoritarian election district shall be set up within the boundaries of Poti City municipality, local majoritarian election districts of Supsa and Grmagele of Lanchkhuti municipality and local majoritarian election districts of Natanebi and Ureki of Ozurgeti municipality.

33. 1 majoritarian election district shall be set up within the boundaries of Martvili municipality and Abasha municipality, except for the local majoritarian election districts of Norio, Zanati and Tskemi.

34. 1 majoritarian election district shall be set up within the boundaries of Senaki municipality and the local majoritarian election districts of Norio, Zanati and Tskemi of Abasha municipality.

35. 1 majoritarian election district shall be set up within the boundaries of Khobi municipality and the local majoritarian election districts of Ergeti, Narazeni, Tsaishi, Chitatskari, Oktomberi, Akhalsopeli and Didi Nedzi of Zugdidi municipality.

36. 1 majoritarian election district shall be set up within the boundaries of Zugdidi City municipality and the local majoritarian election district of Abastumani of Zugdidi municipality.

37. 1 majoritarian election district shall be set up within the boundaries of Zugdidi municipality, except for the local majoritarian election districts of Abastumani, Ergeti, Narazeni, Tsaishi, Chitatskari, Oktomberi, Akhalsopeli and Didi Nedzi.

38. 1 majoritarian election district shall be set up within the boundaries of Tsalenjikha and Chkorotskhu municipalities.

39. 3 majoritarian election districts shall be set up within the boundaries of Batumi City municipality and the local majoritarian election districts of Khala, Chaisubani, Sachino, Chakvi and Tsikhisdziri of Kobuleti municipality.

40. 1 majoritarian election district shall be set up within the boundaries of Kobuleti municipality, except for the local majoritarian election districts of Khala, Chaisubani, Sachino, Chakvi and Tsikhisdziri.

41. 1 majoritarian election district shall be set up within the boundaries of Khelvachauri municipality and local majoritarian election district of Makhuntseti of Keda municipality.

42. 1 majoritarian election district shall be set up within the boundaries of the municipalities of Khulo and Shuakhevi and Keda municipality, except for the local majoritarian election district of Makhuntseti.

Article 110^2 . Peculiarities of determining the powers of DEC and its head officials during the elections of the Parliament of Georgia

1. Powers and operation areas of DECs, set up in accordance with paragraph 2 of Article 19 of this Law, shall be determined by the CEC ordinance according to this Article for the elections of the Parliament of Georgia.

2. CEC decree shall determine

a) DECs, which during the elections of the Parliament of Georgia shall fully exercise the powers prescribed by Article 21 of this Law, and their operation areas.

b) DECs, which during the elections of the Parliament of Georgia shall partially exercise the powers prescribed by Article 21 of this Law, and their powers.

3. Only one DEC shall exercise full authority on the territory of every election district;

4. The ordinance prescribed by paragraph 2 of this Article shall be adopted by CEC within the period specified by paragraph 4 of Article 110 of this Law.

5. During the elections of the Parliament of Georgia, subparagraphs "e" and "f" of paragraph 1 of Article 22 of this Law and subparagraphs "b-d" of paragraph 3 of the same Article shall not apply to head officials of DECs defined by subparagraph "b" of paragraph 2 of this Article.

Article 3. This Law shall enter into force upon promulgation.

Explanatory Note

On the Organic Law of Georgia 'on Changes to the Election Code of Georgia'

• Reason for the adoption of the organic draft law:

Adoption of the organic draft law of Georgia is determined by the ruling of 28 May 2015 of the Constitutional Court of Georgia. The Constitutional Court recognized the part of the Paragraph 1 of Article 110 of the organic law of Georgia "Election Code of Georgia", prescribing that for the regular elections of the Parliament of Georgia 10 majoritarian election districts shall be established in Tbilisi, incompatible with Article 14 and paragraph 1 of Article 28 of the Constitution of Georgia. As stated in the ruling of the Constitutional Court, "according to the information published by CEC, number of voters registered in 10 election districts of Tbilisi exceeds 1 million voters, while 3 613 851 voters are registered in election districts of Tbilisi, and out of 73 mandates 10 mandates are distributed in Tbilisi, i.e. 14% of mandates. Respectively, in case there are 10 single-mandate majoritarian election districts in Tbilisi, it is impossible to establish 63 commensurate single-mandate election districts nationwide.

For visibility, see Annex 1, depicting current situation in election districts.

In its ruling, the Constitutional Court of Georgia emphasized the importance of equal voting power as an international standard and indicated that "equal voting power principle is a widely recognized international standard. For example, similar standards are envisaged by the European Commission for Democracy through Law (Venice Commission) in its recommendations. According to the Venice Commission 2002 "Election Code Provisions", equal voting power is one of the basic election principles, which seeks to establish the electoral districts in a manner as to distribute the respective mandates according to the number of voters. At the same time, deviation from the established norm should not exceed 10%, except for special cases (protection of densely populated national minorities, sparsely populated administrative unit). In such cases, deviation should not exceed 15%. Indications on equal voting power principle, related to the electoral law of Georgia, is included in recommendations of the Organization for Security and Co-operation in Europe (OSCE) and the Venice Commission."

Therefore, since acting provisions of the Election Code of Georgia do not provide the principle of equal voting power, it became necessary to prepare changes to respective

provisions of the election code for general elections of the Parliament of 2016 and the creation of the election districts based on the acceptable deviations indicated in the aforementioned ruling of the Constitutional Court.

Content of the changes to the Election Code:

The Election Code envisages following changes:

For the election of the Parliament of Georgia, the ground for establishment of election districts will be equal distribution, to a feasible extent, of voters in constituencies, thus, bringing provisions of the Election Code in compliance with international standards.

For the regular elections of the Parliament of Georgia, majoritarian election districts will be set up in accordance with Article 110^1 of the Election Code. Consequently, the election district territories are defined by Article 110^2 of the Election Code, except for 4 cities, where it is envisaged to set up two or more election districts - the boundaries of election district in these cities shall be set by CEC.

It is worth noting that in Tbilisi, 22 instead of 10 elections districts shall be established. In 7 municipalities, one majoritarian election district each shall be set up. In the rest of Georgia, 44 election districts shall be established through unifying or, on the contrary, dividing municipalities, or through adjoining to municipality/municipalities local majoritarian district/districts of other municipality. The parts separated from municipalities shall be composed of local majoritarian election districts that were created for the last municipal elections conducted before the parliamentary elections.

As a result of such division, in 61 electoral districts the deviation in average voting power will be within a 10% range. In 12 electoral districts - it will be within a 15 % range.

For visibility, see Annex 2 that depicts new structure of election districts and number of voters.

Boundaries of single-mandate election districts will not be changed until the next regular elections, despite the possible changes in administrative boundaries of municipalities or voter migration. Boundaries of election districts can only be changed before the next regular elections, no later than June 1 of the regular elections and no sooner than December 1 of the previous year.

For establishment of single-mandate election districts latest data of electronic database of general voters lists, maintained by CEC, shall be used.

The existing 73 election districts have been kept, for they are also responsible for municipal elections. However, because election districts are to be set up through splitting the territory of a municipality, through adjoining the territories of municipalities or through adjoining one part of a territory of a municipality to the territory of another municipality, DEC operation areas are also to be determined in a different manner. Namely, for the next regular elections, a CEC ordinance will determine DECs, which shall have the full authority to conduct parliamentary elections in a single-mandate election district/districts, and their operation areas. In addition, CEC ordinance will determine the DECs, which, during the parliamentary elections, will be subordinate to the above-mentioned commissions and exercise auxiliary functions.
